Rickreall Creek a tributary of Willamette River

for the purpose of

under Permit No. 18789 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 20, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.154 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE 4 SE4, as projected on Nathaniel Hudson D.L.C. #46, Section 35, Township 7 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.4 acres in NE SE, as projected on Nathaniel Hudson D.L.C. #46, Sec. 35;

O.l acres in SWA NWA.

0.3 acres in Lot 2 (SE NWA)

3.3 acres in Lot 3 (NW $\frac{1}{4}$ SW $\frac{1}{4}$) 3.2 acres in Lot 4 (SW $\frac{1}{4}$ SW $\frac{1}{4}$)

Section 36; Township 7 South, Range 6 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beg 87 links W of NE corner of DLC of Nathaniel Hudson 7-5, running N 29.00 chs, thence E. 9.00 chs; thence N 59° 30' E 8.00 chs; E 7.00 chs to center of LaCreole River, thence down the center of said River to Wline of DLC of G. L. Tuthill; thence S 37.75 chs to lands sold to Geo L. Hawkins, thence N 86° W 50 links, thence S 67° W 1.62 chs; S 20° W 2.72 chs; S 35° E. 1.76 chs; E 2.00 chs to S% corner of said Tuthill DLC thence S 3.20 chs to land sold to Fred Hughes, thence S 78° 45' W 2.62 chs; S 49° 30' W 1.37 chs; S 5° W 1.86 chs; S 30° 30' W 3.03 chs, thence S 5° 30' W e.59 chs; W 6.82 chs to most S'ly NW corner of lands deed to Georgia I. Robbins, thence W 18.80 chs to NW corner of Robbins tract, thence S. 13.83 chs, thence W 38.68 chs; N 40.87 chs to N line of Nathaniel Hudson DLC, thence E 41.90 chs to p-o-b, cont 319.96 acres m or 1 except that certain tract of land conveyed to Edgar L Miller in Volume 107-74 and that certain tract of land conveyed to John E. Martin in Volume 80-32.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
