19288 under Permit No. of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Larch 6, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.30 cubic feet per second, being 0.27 c.f.s. from waste water and 0.03 c.f.s. from marsh,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE SN , Section 16 & Lot 6 (NE NN), Section 21, Township 36 South, Range I, West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{1}{12}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year, and shall also be limited to the water available at the proposed point of diversion, and shall not carry with it the right to compel the continuance of the waste water,

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 9 acros in SE4 SW4, Sec. 16, T. 36 S., R. 4 W., W.M. 3 acres in Lot 6 (NE4 NW4), Sec. 21, T. 36 S., R. 4 W., W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

TRACT D: All that portion of the Southeast quarter of the Southwest Quarter of Section 16 in Township 36 South, Range 4 West of the Millamette Meridian, in Jackson County, Oregon, lying northwesterly of the right-of-way of the Oregon and California Railroad Company. EXCEPTING therefrom the following: Beginning at the mortheast corner of the Southeast Quarter of the Southwest Quarter of said Section 16; thence West 1000.0 feet; thence South 880.0 feet; thence East 100.0 feet to the northwesterly line of the County Road; thence Northeasterly along said road line 850.0 feet, more or less, to the east line of said quarter-quarter; thence North 225.0 feet to the point of beginning; TRACT E: Beginning at the south quarter corner of Section 16 in Township 36 South, Range 4 West of the Willamotte Meridian, in Jackson County, Oregon; thence North, along the north and south center line of said Section, a distance of 217.0 feet to a point on the southeasterly right-of-way line of the Oregon and California Railroad Company; thence Southwesterly along said right-of-way line a distance of 438.6 feet; thence South 359.7 feet; more or less, to a point on the northerly bank of Rogue River; thence Northeasterly along said bank to a point due south of the point of beginning; thence Northeasterly along said bank to a point due south of the point of beginning; thence Northeasterly along said bank to a point was herein described.
