CERTIFICATE OF WATER RIGHT

This Is to Certify, That

PAUL D. GREEN

of 837 Willamette Street, Eugene, State of Oregon, of a right to the use of the waters of the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Middle Fork Willamette River, Rattlesnake Creek, Alder Creek atributary of Willamette River for the purpose of irrigation under Permit No. 16729 of the State Engineer, and that said right to the use of scid waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 24, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed O.hl cubic feet per second, being O.ll c.f.s. from Willamette River, O.ll c.f.s. from Rattlesnake Creek, and O.l3 c.f.s. from Alder Creek,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 (NE2 SE2); Lot 4 (SE2 SE2); & SW2 SE2 as projected within Abel H. Bristow D.L.C. #67; Section 36, Township 18 South, Range 2 West, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

O.h acres in SE\(\frac{1}{2}\) SN\(\frac{1}{4}\), as projected on Levi Linder D.L.C. #\(\frac{1}{4}\)2;
O.5 acres in NE\(\frac{1}{2}\)5 SE\(\frac{1}{4}\), as projected on Abel H. Bristow D.L.C. #\(\frac{1}{6}\)7;
7.2 acres in Lot \(\frac{1}{4}\) SE\(\frac{1}{4}\)5 SE\(\frac{1}{2}\);
2.2 acres in SE\(\frac{1}{4}\)5 SE\(\frac{1}{4}\), as projected on Abel H. Bristow D.L.C. #\(\frac{1}{6}\)7;
6.\(\frac{1}{4}\) acres in SW\(\frac{1}{4}\)5 SE\(\frac{1}{4}\), as projected on Abel H. Bristow D.L.C. #\(\frac{1}{6}\)7;
0.\(\frac{1}{4}\) acres in NW\(\frac{1}{4}\)5 SE\(\frac{1}{4}\), as projected on Abel H. Bristow D.L.C. #\(\frac{1}{6}\)7;
All in Section 3\(\frac{1}{6}\), Township 18 South, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Lots 1, 2, 3, and all of 4 except 6 and 59/80 acres in the Southwest corner of said Lot 4 (said executed tract being 42 rods East and West and 25 2/3 rods North and South) all being in Section 36, Township 18 South, Range 2 West of the Willamette Meridian. Also beginning at the Southeast Corner of the Abel K. Bristow and wife Donation Land Claim #67, Notf. #7045 in the above Township and Range, thence West 19 chains, thence North 5 chains and 26.3 links, thence 19 chains to the east line of said claim, and thence South 5 chains and 26.3 links to the place of beginning, Also beginning at a point on the south line of the Abel K. Bristow and wife, Donation Land Claim #67, in Township 18 South, Range 2 West of the Willamette Meridian 28.72 chains East from the Southwest Corner of said claim and running thence East 32.82 chains to the West line of lands now belonging to the grantee in deed filled May 22, 1920, recorded in Book 123 Page 567, deed records, Lane County Oregon., thence North 20 feet, thence West 32.87 chains to a point 20 feet north of the place of beginning and thence South 20 feet to the place of beginning, in Lane County, Oregon to be used for road purposes only.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
