CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALVIS E. CURL

of Box 264, Coos Bay , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

an unnamed creek atributary of Coos River

for the purpose of

irrigation
under Permit No. 15818 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from June 12. 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.11, cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE1 NV1, Section 32, Township 25 South, Range 12 West, W. N.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

11.0 acres $\inf_{N} Sw_4^2$ NE_2^2 , Section 32, Township 25 South, Range 12 West, W.M. Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point which bears South 52° 15' West 218.5 feet from an iron pipe marking the center of the Northeast Quarter (NE%) of Section 32, Township 25 South Page 13 West of the Willamette Meridian and running thence South 52° 15' West 76.5 act to an iron pipe; thence North 59° West 274 feet, more or less, to the North boundary of the Southwest Quarter of the Northeast Quarter (SWANE%) of the Said Section 32; thence West along the North boundary of the said Southwest Quarter of the Northeast Quarter (SWANE%) of said Section 32, 800 feet, more or less to the Northwest corner thereof; thence South along the West boundary of the said Southwest Quarter of the Northeast Quarter (SWANE%) of Section 32, 1320 feet, more or less, to the Southwest corner thereof; thence East along the south boundary of the said Southwest Quarter of the Northeast Quarter (SWANE%) of Section 32, 1147.2 feet; thence North 1186.2 feet, more or less, to the place of beginning. Containing 34 acres, more or less, together with the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
