CERTIFICATE OF WATER RIGHT

This Is to Certify, That JACK & SYLVIA GAULKE

of Canyonville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River a tributary of irrigation for the purpose of irrigation under Permit No. 17459 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 6, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.31 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Joel Thorn DLC #44, Section 9, Township 30 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 18.8 acres in Lot 15 (SW $\frac{1}{4}$ SE $\frac{1}{4}$);
- 6.2 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Joel Thorn D.L.C. #44;
- Section 9, Township 30 South, Range 4 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point 20.00 chains North & 2.95 chains East from the $\frac{1}{4}$ Section corner between Section 9 & 16, Twp. 30 S. R. 4 W. W. M. Thence North 9° 30' East 12.40 chains To the center of the South Umpqua River, Thence Following The center of South Umpqua River up stream S. 59° 45' E. 14.04 chains, Thence S. 9° 30' W. 25.70 chains To the line between Sections 9 & 16, Thence W. with said section line 12.03 chains, Thence North 9° 30' East 20.27 chains To The Place of Beginning, containing 35 acres, more or less, in The County of Douglas, State of Oreg.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
