, State of , has made proof Days Creek Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River

a tributary of Umpqua River irrigation

for the purpose of

under Permit No. 17767 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 27, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.057 cubic feet per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 9, (NE SE4), Section 23, Township 30 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 21 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Nows: 2.6 acres in Lot 8 (SE NE 1)
2.7 acres in Lot 9 (NE 1 SE 1)
Section 23, Twp. 30 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

All of Lot No. 9 Sec 23, T 30 S, R h W, lying east and north of the South Umpqua River. All of Lot No 6 Sec 24. T 30 S. R h W. All of Lots No 2, 3 Sec 2h and Lots River. All of Lot No 6 Sec 24.7 30 S. R 4 W. All of Lots No 2, 3 Sec 24 and Lots nos. 1, 2,7 and 8 Sec 23 lying east of the South Umpqua River, and south of the following described line: Beginning at a point which bears north 40 degree 51 min. East 1981.6 ft. distant from the quarter (1) corner between sections 23 and 24 Township 30 South. Range 4 West W. H. Douglas County, Oregon. Said point is a serpentine stone 7 x 10 x 14 ins from which a white oak 10 ins in dia bears N 65 degrees 40 min ¥ 32.7 ft and a black oak 40 ins in dia bears S 11 degrees and 30 nin ¥ 39.1 ft thence S 73 degrees and 15 min ¥ 1361 ft on partition line to a 5/8 x 24 inch iron rod. S 70 degrees and 50 min 1302 ft on partition line to a blue basalt stone 8 x 9 x 18 ins. A black oak 30 ins in dia bears N 19 degrees and 10 min E 16 feet and 9 inches distant and a black oak 30 ins in dia bears S 35 degrees and 15 min E 16 feet and 5 ins distant. Thence S 70 degrees and 50 min W 100 feet to the north edge of the South Umpqua River, containing 137 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
