CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** H. S. & BEULAH HORTON

of P. O. Box 536, Coquille, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Rink Creek for the purpose of domestic use for one family under Permit No. 13908 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 5, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 8, Township 28 South, Range 12 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: Domestic in SW $\frac{1}{4}$  NW $\frac{1}{4}$ , Sec. 8, T. 28 S., R. 12 W., W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point on the quarter section line North 87° West 10 feet from the  $\frac{11}{4}$  section corner on line between the NW and SW quarters of Section 8, Township 28 South of Range 12 West of the Willamette Meridian and running thence North 87° 00' West along said quarter section line a distance of 1017 feet to the East boundary of a proposed 30 foot roadway; thence North 13° 20' East along the East boundary of said proposed roadway 800 feet, more or less, to the left bank of Rink Creek; thence along said left bank of Rink Creek up stream approximately as follows: North 71° East 100 feet; thence South 74° 10' East 520 feet; thence North 63° 15' East 293 feet more or less, to a point 820.5 feet North of the place of beginning; thence South parallel with and 10 feet West of the quarter section line running North and South through said Section 8 a distance of 820.5 feet to the place of beginning, containing 16.06 acres of land, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
