CERTIFICATE OF WATER RIGHT

This Is to Certify, That GERALDINE L. & PAUL M. MARTIN

of Route 2, The Dalles , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well

a tributary of

for the purpose of

irrigation and supplemental irrigation under Permit No. U-180 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 11, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.43 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 4 (NW4 NW4), Section 23, Township 1 North, Range 12 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—sixtieth of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season from April 1, to October 1,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the southwest corner of the Northwest quarter of Sec. 23, T. 1 N., R. 12 E.W.M., thence north along section line high feet; more or less to the northwest corner of Lot 5, Sec. 14, T. 1 N., R. 12 E.W.M. thence east along the north line of said Lot 5, 1003 feet, more or less; thence south 2002 feet, more or less, to the center line of the Mill Creek Market Road, thence northeasterly along said center line 200 feet, more or less, to a point 71.2 feet east of the west line of the Colwell D. L. Claim, thence south 822 feet, more or less; thence N 52° Oh! E., 300 feet; thence N 19° 57' E., 301 feet to the south line of said Colwell D. L. Claim, thence east along the south line of the Colwell D. L. Claim, 1022 feet more or less to the northeast corner of lot 3, Sec. 23, T. 1 N., R. 12 E.W.M.; thence south 570 feet, more or less to the top of rock bluff thence southwesterly along the top of said rock bluff; to the south line of northwest quarter of Sec. 23, T. 1 N., R. 13EW.M.; thence West 607 feet, more or less to the point

of beginning, Contains 114.76 acres, more or less, save and except the rights of way of the Mill Creek Market Road, save and except certain ditch rights from Mill Creek, heretofore deeded to H. R. Fowler place.

Also beginning at a point 330 feet West of the Southeast corner of the West onethird of the West half of the Colwell Donation Land Claim, thence S. 49° 57' W. 301 feet, thence south 800 feet, more or less, to Bluff line thence Easterly along said Mluff line 570 feet, more or less, thence Horth 990 feet, more or less, thence West 330 feet to place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
