CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. DALE HATFIELD

of Box 53, Scio, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Thomas Creek a tributary of South Fork Santiam River a trib. of Santiam River for the purpose of irrigation under Permit No. 15796 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 31, 1944,

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$ & SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on Elijah F. McKinney D. L. C., Section 18, Township 10 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 5.4 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Elijah F. McKinney D. L. C.
- 3.2 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on Elijah F. McKinney D. L. C.

Section 18, Township 10 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

All of Lots numbered 11 and 12 as appears and is designated upon the recorded plat of Goins Land Plat to Scio, Oregon, as appears of record at page 15, Vol. 2, Record of Plats, in and for Linn County, Oregon, in the office of the Recorder of Conveyances in and for Linn County, Oregon, and containing 23.73 acres more or less, all situate lying and being in Section 18 in Township 10 South, of Range 1 West of the Willamette Meridian and in Linn County, State of Oregon, save and excepting from the above described premises a small strip of land conveyed to Sticha and 3 acres and a fraction of an acre conveyed to Prohaska, from and off of the South end of said Lot 11, leaving conveyed by this deed 20.10 acres of land. This is the former Ed Kalina property which we contracted for June 15, 1943.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
