## CERTIFICATE OF WATER RIGHT

This Is to Certify, That WILLAMETTE NATIONAL LUMBER COMPANY

of Dallas , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Santiam River and log pond constructed under App. No. R-21568, Per. No. R-841 a tributary of for the purpose of

pond loss, industrial use and fire protection under Permit No. 16918 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 19. 1946

that the amount of water to which such right is entitle and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 10.0 cubic feet per second, being 0.8 c.f.s. for pond loss; 9.2 c.f.s. for industrial use and fire protection,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SE_4^{\frac{1}{2}}$   $IW_4^{\frac{1}{2}}$ , Section 26, Township 13 South, Range 1 East, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

NW1 SW1, as projected on Milton Humphrey D. L. C. No. 38
SW2 SW2, as projected on Milton Humphrey D. L. C. No. 38
Section 26;
NE1 SE2, as projected on Milton Humphrey D. L. C. No. 38

NET SET, as projected on Milton Humphrey D. L. C. No. 38 SET SET, as projected on Milton Humphrey D. L. C. No. 38 Section 27;

NE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, as projected on Milton Humphrey D. L. C. No. 38 Section 34; Township 13 South, Range 1 East, W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the southeast corner of the Donation Land Claim of Milton Humphrey, Claim No. 38 in Township 13 South of Range 1 East of the WillametteMeridian in Linn County, Oregon, running thence west 26.0 chains; thence south 806.41 feet, more or less, to the center of the Wiley Creek County Road; thence northwesterly along the center of said road about 1860.0 feet to a point; thence north 26.8 feet to an iron pipe; thence north 1581.2 feet to an iron pipe on the south boundary of the South Santiam Highway, which iron pipe is due south of a point which is 100.0 feet distance southwesterly along the center of said highway from the center of a stock underpass; thence N. 76° 53' E. along the south boundary of said highway 2896.1 feet, more or less; to the east boundary of Scholl's property, which east boundary is 5.0 chains west of the east line of Claim No. 38; thence south 710.0 feet; thence N. 67½° E. 5.55 chains to the east line of Claim No. 38; thence South 28.20 chains to the place of beginning, containing 168.0 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
