CERTIFICATE OF WATER RIGHT

This Is to Certify, That EDWARD REILING

of 1185 S. Water St., Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Silver Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 18416 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 10, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.08 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on James Smith D.C. #54, Sec. 2, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: 1.8 acres in Lot 2 (SW $\frac{1}{4}$ NE $\frac{1}{4}$) 3.4 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on James Smith D.L.C. #54 1.2 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on John Barger D.L.C. All in Section 2, Township 7 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point North 40° 30' West 3.151 chains from a rock 10"x10"x10" 36.70 chains West, 10 links North of the Quarter corner between Sections one and two (2) in Township 7 South, Range 1 W., of the Willamette Meridian in Marion County, Oregon; thence North 49° 30' East 9.52 chains; thence North 40° 30' West 7.353 chains to a rock 10"x12"x14"; thence South 49° 30' West 9.52 chains to a rock 8"x10"x14" in the center of the County Road; thence South 40° 30' West 7.353 chains along said Road to the place of beginning, and containing 7 acres, more or less, all in the D.L.C. of James Smith and wife.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
