CERTIFICATE OF WATER RIGHT

This Is to Certify, That MRS. ARRILLA B. WILSON

of Route 1, Box 56, Warren, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream a tributary of Deep Creek, a tributary of Scappoose Creek for the purpose of domestic for one family, including irrigation of garden not exceeding $\frac{1}{2}$ A. in area. under Permit No. 16116 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 12, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 34, Township 4 North, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows: SE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 34, T. 4 N., R. 2 W., W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at a point that is South 3 deg. 7' East 659.7 ft. and North 86 deg. 50' East 1532.4 feet and South 1 deg. 30' east 218 ft. from the Northwest corner of Section 34, T. 4 N. of R. 2 W. of W. M.; thence North 86 deg. 50' East 300 ft. thence southeasterly to a point on the east boundary line of tract #7 described in book 17, page 247, deed records of Columbia County, thence South 1 deg. 30' East 160.7 ft.; thence West 75 ft.; thence South 1 deg. 30' East 290.3 ft. to center of road established by Margaret D. Reid and surveyed by C. M. Thomas; thence north westerly along said road to a point South 1 deg. 30' East of point of beginning; thence North 1 deg. 30' West to point of beginning, containing 9 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
