## CERTIFICATE OF WATER RIGHT

This Is to Certify, That CHARLES J. KAFER

of Olendale , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

Rattlesnake Creek a tributary of Cow Creek

for the purpose of

irrigation under Permit No. 17588 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 4, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SW4, Section 12, Township 33 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—seventiath of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season from April 1st to October 1st of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the Southwest Quarter of the Northeast Quarter of Section 2, Township 33 South, Range 7 West of the Willamette Meridian; thence North a distance of 1609 feet, more or less to a point in the center of the F.S. road; thence following in an easterly direction along said road North 80° 25' East a distance of 162 feet to a point; thence North 71° 14' East a distance of 119 feet to a point; thence South 85° 04' East a distance of 323 feet to a point in the center of said F.S. road at the thread of Rattlesnake Creek; thence South a distance of 1724 feet, more or less, to a point on the South line of the Northeast quarter of the Southwest quarter of Section 2, Township 33 South Range 7 West of W.M.,; thence West along said South line a distance of 738 feet to the place of beginning, containing 28.05 acres, more or lesse right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
