CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. C. VAN VALKENBURGH

of Route 2, Box 590, Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River a tributary of Pacific Ocean for the purpose of irrigation under Permit No. 17854 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 28, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.36 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 6 (NW $\frac{1}{4}$ SE $\frac{1}{4}$), Section 13, Township 36 South, Range 7 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $1\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

8.0 acres in Lot 6 (NW $\frac{1}{4}$ SE $\frac{1}{4}$)
17.0 acres in Lot 7 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)
4.0 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$

Section 13
Township 36 South, Range 7 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

East Half (E 1/2) of East Half (E 1/2) of Southeast Quarter (SE 1/4) of Section 14, Township 36 South, Range 7 West of Willamette Meridian, Josephine County, Oregon. The North West quarter of the South West quarter of Section thirteen (13) Township thirty-six (36) South of Range Seven (7) West. Lots Six (6) and Seven (7) in Section thirteen (13) and lot no. Five (5) in Section fourteen (14) in Same Township and Range.

Also that tract or parcel of land described as follows; Beginning at the North East corner of the North West quarter of the South East quarter of Section fourteen (14) Township Thirty-Six (36) South of Range Seven (7) West running thence West Eleven (11) Chains, thence South twenty (20) Chains, thence East eleven (11) Chains, thence North twenty (20) Chains to place of beginning Containing twenty two (22) acres. All of the above lands being situated in Josephine County, Oregon. Also lots no. eight (8) in Section no. (13) Township Thirty Six (36) South of Range Seven (7) West Containing $19\frac{3}{4}$ acres of land Situated lying and being in the County of Josephine, State of Oregon

Also Lots 5 and 6 and East one half of Lot 10 and the Northwest quarter of the Southeast quarter and all of the Southwest quarter of the Southeast quarter lying North of the County Road. All located in Section 14 T. 36 S. R. 7 W., W. M. County Josephine, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
