CERTIFICATE OF WATER RIGHT

This Is to Certify, That E. L. JOHNSON

of Route 1, Crowson Rd., Ashland , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Toleman Creek

a tributary of Neal Creek, a tributary of Rear Creek irrigation

for the purpose of

under Permit No. 19736 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 31, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.000 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the NWA SWA, Section 13, Township 39 South, Range 1 East, W. N.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{1}{12}$ acre feet per acre for each acre irrigated during the irrigation season from April 2 to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1/2 acre in NW4 SW4
Section 13
Township 39 South, Range 1 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Commencing at a point on the southeasterly side line of Crowson Road, from which point the northwest corner of Donation Land Claim No. 54 in Township 39 South, Range 1 East of the Willamette Meridian in Jackson County, Oregon, bears North 21.31 feet, and West 1482.73 feet distant; thence along the said line of Crowson Road, South 49° 55' West 358.96 feet to the true point of beginning; thence along Crowson Road South 50° 31' West 200 feet; thence South 39° 29' East 265 feet to the center line of Tolman Creek; thence along said creek North 1° 36' West 178.75 feet; thence North 20° 19' East 102.25 feet to the South line of that portion deeded to Eaxter; thence along said line North 40° 05' West 71 feet to the true point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
