**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** CLIFFORD G. LOCKHART

of Murphy, Route 1, Box 29, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Waste Water a tributary of Applegate River for the purpose of irrigation under Permit No. 17711 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 21, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 30, Township 37 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year, and shall also be limited to the water available at the proposed point of diversion, and shall not carry with it the right to compel the continuance of the waste water,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.10 acres in SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 19, Township 37 South, Range 5 West, W. M.  
0.06 acres in NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 30, Township 37 South, Range 5 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at the Northeast corner of Tract five (5) of Madrona Tracts, as platted and on file in the office of the County Clerk of Josephine County, Oregon, running thence Northwesterly along the North line of said Tract, a distance of 90.6 feet; thence Southwesterly and parallel with the East line of said tract, a distance of 483.7 feet; thence Southeasterly along the South line of said Tract, a distance of 90.6 feet; thence Northeasterly along the East line of said Tract, a distance of 483.7 feet to point of beginning, containing one acre, more or less, together with all water or water rights, ditch or ditch rights appertaining thereto. Less and excepting a 30 foot roadway along the North line of said Madrona Tract 5.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
