of 500 East Park Street, Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rogue River

under Permit No. 1872? of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 18, 1949

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed G.Ol cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (SW; NW;) in Section 20, Township 36 South, mange 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightlieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre (seek per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acres in Lot 5 (Silk News), Section 20, Township 36 South, Range 5 West, W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Seginning at a point 975.48 feet East and 972.1 feet North of the West one Quarter corner of Section 20 in Township 36 South, Range 5 West of the Willamette Meridian; thence West and parallel with the North line of Fark Street 315.4 feet; thence North 288.5 feet; thence South 84° 02' East along the face of a 6" in width concrete curb 174 feet; thence North 6°13' East, along the face of a 6" concrete curb 182 feet; more or less to Rogue River; thence Easterly 130 feet more or less, along Rogue River to a point which is North of the point of beginning; thence South 440 feet more or less to the point of beginning containing 2.6 acres more or less.

The right to the use of the water for the purposes of oresaid is restricted to the lands or place of use herein described.
