CERTIFICATE OF WATER RIGHT

(For rights perfected under original, enlargement or secondary permits)

This is to Certify, That J. L. WRIGHT

of Perdue, State of Oregon, has made proof to the satisfaction of the STATE WATER BOARD of Oregon, of a right to the use of the

waters of St. Johns Creek and Raymond Reservoir ~~xxxxxxx~~ as described in Reservoir Permit No. 260, certificate of water right recorded in Vol. 3, Page 1999, State Record of Water Right certificates, a tributary of South Umpqua River, for the purpose of the irrigation of 50 acres of land under Permit No. 1836 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and duly confirmed by order of the STATE WATER BOARD of Oregon, made and entered

of record in the Record of Proceedings of said Board, at Salem, in Volume 1

at page 280, on the 9th day of March, 1918; that the priority of the right hereby confirmed dates from December 9, 1913; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not

exceed 0.62 cubic foot per second, or its equivalent in case of rotation. The use hereunder shall conform to any reasonable rotation system ordered by the proper State Officer. ~~A description of the lands under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:~~ Six and one-half acres in the Southwest quarter of Southwest quarter of Section Twenty-seven; twelve and one-fourth acres in the Southeast quarter of Southeast quarter; six and one-half acres in the Southwest quarter of Southeast quarter; eight and one-fourth acres in the Northwest quarter of Southeast quarter and nine and one-half acres in the Northeast quarter of Southwest quarter of Section Twenty-eight and seven acres in the Northwest quarter of Northwest quarter of Section Thirty-four, Township Thirty South, Range Three West of Willamette Meridian, in Douglas County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes, as hereby confirmed and limited.
