of Route 1, Box 58, Ashland, , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Butler Creek

under Permit No. 20025 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from December 1, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.013 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL NEL, Section 31, Township 38 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

One acre in SE, NEA, Section 31, Township 38 South, Range 1 East, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point on the center line of County Road near South end of (former) bridge over Bear Creek 16.28 chains North and 9.88 chains West of the Southeast corner of D. L. C. # 48 in Township 38 South of Range 1 East of Willamette Meridian, Oregon; thence North 31°30' West along center of said road 1.51 chains; thence North 61°30' Vest along center line of said road 8.74 chains; thence North 66° 30' West along center line of said road 9.80 chains; thence North 67° 15' West along center line of said road; 5.73 chains; thence North 51°30' West along center line of said road 3.53 chains; thence South 11.64 chains; thence South 67° 45' Last 22.01 chains; thence North 57° Last 2.60 chains to the place of beginning, containing 23.8 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
