CERTIFICATE OF WATER RIGHT

This Is to Certify, That SILVESTER C. HITSON

of Route 1, Box 178, Rogue River, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Ditch Creek a tributary of Pleasant Creek, tributary of Evans Creek for the purpose of irrigation under Permit No. 18173 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 30, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 29, Township 34 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$
6 acres in NE $\frac{1}{4}$ SW $\frac{1}{4}$

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point which is 159 feet North and 96.0 feet East of the west quarter corner of Section 33 in Township 34 South, of Range 4 West of the Willamette Meridian, in Jackson County, Oregon; thence running North 37° 20' East 2018.3 feet to the east line of the Northwest Quarter of the Northwest Quarter of said Section 33; thence South 444.0 feet to the northwest corner of the Southeast Quarter of the Northwest Quarter of said Section 33; thence East 1320 feet to the Northeast corner of said quarter-quarter section; thence South 2640 feet to the southeast corner of the Northeast Quarter of the Southwest Quarter of said Section; thence West along the south line of said quarter-quarter section (and said line extended) 3672 feet to a point from which the point of beginning bears North 37° 20' East; thence North 37° 20' East 1864.7 feet to the point of beginning; EXCEPTING therefrom the following: Beginning at a point which is 159 feet North and 96.0 feet East of the west quarter corner of Section 33 in Township 34 South, of Range 4 West of the Willamette Meridian, in Oregon; thence running North 37° 20' East 700 feet; thence South 52° 40' East 100 feet; thence South 16° West 390.7 feet; thence South 54° West 200 feet, thence South 80° West 100 feet; thence North 86° West 120 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
