CERTIFICATE OF WATER RIGHT

This Is to Certify, That FLORENCE ANDERSON AND ARCHIE E. ANDERSON

of Harbor, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Stream a tributary of Pacific Ocean for the purpose of irrigation under Permit No. 16216 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 7, 1944

; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 9, as projected on Christian Tuttle DLC# 38, Township 41 South, Range 13 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 0.4 acres in NE $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 9, As projected on Christian Tuttle DLC #38
- 3.6 acres in SE $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 9, As projected on Christian Tuttle DLC #38
- All in Township 41 South, Range 13 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: A tract of land lying in Donation Land Claim Number Thirty-Nine (39), being in the East Half (E $\frac{1}{2}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Nine (9), Township Forty-one (41) South, Range Thirteen West of Willamette Meridian, in said County and State; beginning at a point which is North 390.06 feet and East 3192.34 feet from the Southwest (SW) corner of said D. L. C. No. 39; thence North 170.00 feet; Thence East 353.70 feet to a point on the Westerly right of way line of U. S. Highway 101; thence following said highway line Southeasterly (South 41 deg. 37 min. East) 227.30 feet to a point which is due East from the point of beginning; thence West 504.60 feet to the point of beginning, containing 1.35 acres, more or less.....

Land Described as follows,

A tract of land lying in Donation Land Claim Number Thirty-nine (39), being in the East Half (E $\frac{1}{2}$) of the Northwest Quarter (NW $\frac{1}{4}$) of Section Nine (9), Township Forty-one (41) South, Range Thirteen (13) West of Willamette Meridian, said county and state; beginning at a point on the North line of the County Road, said

point being North 60.60 feet and East 2905.98 feet from the Southwest (SW) corner of said D. L. C. No. 39; thence North 645.60 feet; thence East 74.92 feet; thence North 109.00 feet; thence East 211.44 feet; thence South 424.60 feet; thence West 251.00 feet; thence South 130.00 feet; thence West 70.00 feet; thence South 200.00 feet; thence west 191.36 feet to the point of beginning, containing 4.23 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
