**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That P. M. AND MABEL A. CAMPBELL**

of B. B. Route , Cottage Grove , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed Stream a tributary of Coast Fork of Willamette River for the purpose of irrigation under Permit No. 15864 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 18, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.21 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Any point on property where stream touches it in SW NE, SE NE & NW SE, Section 30, As projected on M. E. Anderson DLC No. 40 Township 22 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.1 acres in SE 1/4, NE 1/4, Section 30, as projected on M.E. Anderson DLC # 40  
3.8 acres in SW 1/4, NE 1/4, Section 30, as projected on M.E. Anderson DLC # 40  
3.0 acres in NE 1/4, SE 1/4, Section 30, as projected on M.E. Anderson DLC # 40  
5.8 acres in NW 1/4, SE 1/4, Section 30, as projected on M.E. Anderson DLC # 40  
All in Township 22 South, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point 37.24 chains north and 5.71 chains west of the southeast corner of the M. E. Anderson Donation Land Claim No. 40, and running thence north 9.80 chains, thence south 88° 50' West 16.37 chains, thence south 82° 40' West 3.80 chains to the south boundary of the County road, thence in a southerly and westerly course following the south and west boundaries of said road to the west boundary of section 30, thence south following the said west boundary of said section 30 to a point 20 chains north of the southwest corner of section 30, thence north 89° 40' east to a point 82 links south 45° west from corner on Donation Line, thence North 45° east 82 links to said corner on said line, thence north following the west boundary of D. L. C. No. 40, 13 chains, thence south 87° east 13.33 chains thence south 8° 30' East 2.16 chains; thence north 80° east 4.85 chains, thence north 8° 30' west 1.36 chains, thence north 77° 30' east 16.30 chains to the place of beginning, in section 30, Township 22 South, range 3 west of Willamette meridian, in Lane County, Oregon.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
