## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That CONTINENTAL CHEMICAL COMPANY

, has made proof of Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of State of Willamette River a tributary of Columbia River for the purpose of process water supply for an experimental Alumina Plant; also fire protection supply under Permit No. 15823 of the State Engineer, and that said right to the use of said and the last of said a has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 15, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 11.0 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Swit SEz, Section 10, as projected on T. D. heizer DLC No. 38, Township 7 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to of one cubic foot per second per acre.

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

A tract of land in the John Force Donation Land Claim in Section 11. Township 7 South, Range 3 West of the Willamette Meridian, Marion County, Oregon, as follows: Beginning at a point on the West line of said John Force Donation land Claim 6.919 chains (456.65 feet) Northerly from the Southwest corner of said Donation Land Claim; running thence North 12°22' West along the West line of said Donation Land Claim 1952.15 feet to a spike; thence North 89° 57' East along the South line of Hicks Jones Subdivision 2938.97 feet to an iron pipe set as the Southeast corner of said Hicks Jones Subdivision, and being on the West line of the right of way of Oregon Electric Failway Co.; thence South 23° 232' West along said right of way line 1802.15 feet; thence Southerly along said right of way line 200.99 feet on the arc of a curve to the right having a radius of 2834.9 feet, and chord running South 25° 25' 20" West 200.95 feet to a point on the North line of tract of land conveyed by A. N. Bush to Salem Sand and Gravel Co. by deed recorded in Vol. 256, Page 466, Deed Records for Marion County, Oregon thence South 87°32' west along North line of said tract 1720.80 feet to point of beginning, containing 100.023 acres of land, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
