CERTIFICATE OF WATER RIGHT

This Is to Certify, That WALTER I. TRACY

of R.F.D.1, Rainjer , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Beaver Creek

of Columbia River for the purpose of

irright Permit No. of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 20, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.006 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWR SWR, Section 20, Township 7 North, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.5 acre in SW¹₄ SW¹₅, Section 20, Township 7 North, Range 2 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Commencing at the Southwest corner of the SW¹₄ of the SW¹₄ of said Section 20, thence North on the west line of said section 20, 889.2 feet; thence East 1320.0 feet to the east line of said SW¹₄ of SW¹₄, thence south along the east line of said SW¹₄ of SW¹₄ of Sec. 20 to the south line of a private road known as the Phillips and Burnham road, siad point being 544.0 feet North of the Southeast corner of said SW¹₄ of SW¹₄ of said Section 20; thence following the south line of said road in a southwesterly direction 75 feet more or less to the center of Beaver Creek; thence following the center of Beaver Creek to its intersection with the South line of said Sw¹₄; thence West along the south line of said Section 20, 667.0 feet, more or less, to the place of beginning, containing 20 acres, more or less. excepting from the above tract a private road 20 feet wide, heretofore sold to Hi B. Fhillips and D. F. Burnham by deed recorded in Book 14 of deeds, Columbia County, Oregon at page 566, and excepting all of the county road.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
