CERTIFICATE OF WATER RIGHT

This Is to Certify, That W. L. HAYES AND IRA E. HAYES

of Route 4, Box 565, Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Onion Creek a tributary of Applegate River for the purpose of irrigation under Permit No. 17661 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 4, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 18, Township 37 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $4\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year, and shall be still further limited to a diversion of not to exceed 0.04 c.f.s.,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres in SE $\frac{1}{4}$ SW $\frac{1}{4}$, Section 18
3.0 acres in NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 19
All in T. 37 S. R. 5 W. W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Descriptions:

W. L. Hayes

Beginning at a point 485 feet South of the Northwest corner of the Southeast quarter of the Southwest quarter of Section 18 in Township 37 South, Range 5 West of the Willamette Meridian; thence running South 66° 30' East 985 feet; thence South 72° 30' East 182 feet thence South 81° 30' East 253 feet to the East line of the Southeast quarter of the Southwest quarter of said Section; thence South 330 feet; thence West 1320 feet thence North 835 feet to the point of beginning.

F. M. Hayes, Estate

Beginning at the quarter corner between sections 18 and 19 in Township 37 South Range 5 West of the Willamette Meridian; thence running North 330 feet; thence East 51 feet; thence South 429 feet; thence West 1371 feet to the West line of the Northeast quarter of the Northwest quarter of said Section 19; thence North 99 feet; to the Section line; thence East 1320 feet to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
