## CERTIFICATE OF WATER RIGHT

This Is to Certify, That JAMES E. LEWIS

of Myrtle Creek , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Umpqua River a tributary of for the purpose of

Umpqua River irrication under Permit No. 12200 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 1, 1936

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.85 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NEL SWL SWL SWL, Section 6, as projected on Isaac Bailey DLC #40 and NM; NW, Section 7, as projected on Isaac Bailey DLC #40 in Township 30 South, Range 5 West, & ML; NE; Section 12, Township 30 South, Range 6 West. W. M. The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres in SW NE, as projected on William Weaver DLC # 39

0.4 acres in Sw NW, as projected on Isaac Bailey DLC # 40

O.2 acres in SE NW, as projected on ISaac Bailey DLC # 40 O.1 acres in SE NW, as projected on William Weaver DLC # 39 1.7 acres in NW SW, as projected on Isaac Bailey DLC # 40

7.4 acres in 5% SW, as projected on Isaac Bailey DLC # 40 All in Section 6, T. 30 S, R. 5 W., W. M.

33.4 acres in NW NW, as projected on Isaac Balloy DIC # 40
In Section 7, T. 30 S. R. 5 W., W. M.

9.2 acres in SE SE, Section 1, T. 30 S, R. 6 W., W. M.

8.3 acres in NE NE, Section 12, T. 30 S, R. 6 W., W. M.

5.5 acres in SE NE, Section 12, T. 30 S, R. 6 W., W. M.
