## CERTIFICATE OF WATER RIGHT

**This Is to Certify,** That L.B. MCKINLEY

of Route 2 - Sheridan, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Deer Creek a tributary of Yamhill River for the purpose of irrigation

under Permit No. 13752 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 19, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.325 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW SE, SW SE, of Sec. 24: NW NE, NE NE, Sec. 25 as projected in DLC No. 64 and DLC No. 67, T. 5 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.2 acres in NW<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, as projected on Peter Carlyle D.L.C. #64  
 1.5 acres in SW<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, as projected on Peter Carlyle D.L.C. # 64  
 5.9 acres in SW<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, as projected on Wm. Toney D.L.C. # 67  
 0.8 acres in SE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, as projected on Wm. Toney D.L.C. # 67  
 Section 24  
 0.2 acres in NW<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, as projected on Wm. Toney D.L.C. # 67  
 10.4 acres in NE<sup>1</sup>/<sub>4</sub> NE<sup>1</sup>/<sub>4</sub>, as projected on Wm. Toney D.L.C. #67  
 Section 25  
 T. 5 S., R. 6 W., W.M.
