CERTIFICATE OF WATER RIGHT

This Is to Certify, That H. W. and LAURA E. CURRIN

of 134 E. Main St., - Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed stream a tributary of Tualatin River for the purpose of irrigation under Permit No. 16047 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 1, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.09 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW SE & SW SE, Section 12, T. 1 S., R. 3 W., W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.6 acres NW $\frac{1}{4}$ SE $\frac{1}{4}$
1.6 acres SW $\frac{1}{4}$ SE $\frac{1}{4}$
Section 12
T. 1 S., R. 3 W., W.M.

Land on which water is to be used is a part of that more explicitly described as follows: As per deed recorded in Book 209 on page 101 on the 20th day of June 1942, Deed Records of Washington County Oregon, the following is the legal description of the entire place of which the above is only a part of the whole: The West half of the Southeast quarter; the Southeast quarter of the Southwest quarter; and the Southeast quarter of the Southeast quarter of Section 12, T1S-R3W, W. M., excepting from the Southeast quarter of the Southeast quarter all that portion thereof lying east of the County Road, as described in deed to Emet Goff, recorded in Book 91 page 359, Deed Records, and also excepting from said Southeast quarter of the Southeast quarter the south 10 acres thereof as described in deed to Charles W. Marlin, recorded in Book 91 page 57, Deed Records.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
