This Is to Certify, that RAY J. CUININGHAM

of Route 1 - Brownsville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooia River a tributary of Willamette River for the purpose of irrigation under Permit No. 17143 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 11, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0-375 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 NW4, NET, NET, as projected on Elias L. Walter Cl. #38, Sec. 35, T. 13 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer.

Beginning at a point 11.80 chains East of the Northwest corner of the Donation Land
Claim of E. L. Walter and wife, Claim No. 38, in Township 13 South, Range 3 West of
the Willamette Meridian, in Linn County, Oregon, and running thence South 2.75 chains
to the center of Calapooia Creek; thence up the center of said Creek to a point 26.11
chains West of the East line of said Donation Land Claim; thence North to a point
26.11 chains West 15.95 chains South of the Northeast corner of said Donation Land
