The amount of water used for irrigation, together with the amount secured under any other of one cubic foot per second right existing for the same lands, shall be limited to 1/40th per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $3\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.
