CERTIFICATE OF WATER RIGHT

This Is to Certify, That CLYDE WARD

of R. F. D. 1, Baker , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Four wells a tributary of for the purpose of

irrigation and supplemental irrigation under Permit No.U-165 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 23, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 7.2 cubic feet per second, being 2.02 c.f.s. each from Wells No. 1 and No. 2 and 1.58 c.f.s. each from Wells No. 4 and No. 6,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Well No. 1 SE, NW4, Well No. 2 SW4 NE4, Well No. 6 NE4 NE4, Section 7, Township 9 South, Range 40 East, W. M. Well No. 4 SW4 SW4, Section 9, Township 9 South, Range 40 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—fortieth of one cubic foot per second per acre, or its equivalent for each acre irrigated; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

PRIMARY IRRIGATION 40.0 acres in N & SE, Section 6 40.0 acres in SNA SEA, 38.9 acres in SNA SEA, 20.0 acres in NW SW., Section 9 15.3 acres in SWA NEW, SUPPLEMENTAL IRRIGATION Section 7 39.7 acres in NE NWE, 38.9 acres in SW# NE#, Section 6 11 38.6 acres in SE, NE4, 40.0 acres in NW NW, 13 37.1 acres in NET SW4, 36.6 acres in SET SW4, 37.3 acres in NET SET, 42.0 acres in SWI NWI, "
40.0 acres in SEI NVI, "
35.6 acres in SWI SWI, Section 9 n All being in Township 9 South, Range 40 East, W. M.

This certificate is issued to correct and supersede that certain water right certificate previously issued to Clyde Ward and recorded in State Record of Water Right Certificates, Volume 14 at page 19653, so as to correctly describe the lands irrigated as being in T. 9 S., R. 40 E., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
