CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN M. SCHOLTES

, has made proof State of Oregon to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of a well for the purpose of

a tributary of

irrigation and supplemental irrigation under Permit No. 11-253 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 27, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.57 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW SEL, Section 32, T. 15 S., R. 43 E., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/80th of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 32 acre feet per acre for each acre irrigated during the irrigation season of each year; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Primary Supplemental 4.0 acres in NE SWA 5.4 30.0 1.0 acres in NVA SEL Section 32 T. 15 S., R. 43 E., W. M.

Property on which water is to be used is a part of that more explicitly described by applicant as follows:

Northwest Quarter of the Southeast Quarter $(NW_{+} SE_{+}^{2})$ of Section Thirty-Two (32) Township Fifteen (15) South of Range Forty-three (43) East of the Willsmette Meridian, subject to the right-of-way of the East Side Canal of the Orchard Water Company. Also the following described tract in the Southwest Quarter (SW4) of said Section Thirty-two (32) to wit: Beginning at the center of said Section Thirty-Two (32) and running thence West along the North line of the Southwest Quarter (SW2) of said Section Thirty-Two (32) to the intersection of said line of said right-of-way; thence southeasterly tracing the Mortheasterly line of said right-of-way to its intersection with the line between the East half of the Southwest Quarter $(\mathbb{R}^1_2 \mathbb{S} \mathbb{M}^1_+)$ and the West Half of the Southwest Quarter $(\mathbb{W}^1_2 \mathbb{S} \mathbb{W}^1_+)$ of said Section Thirty-two (32); thence Southerly tracing said line to its intersection with the Left bank of Willow Creek; thence Southeasterly with the meanders of said left bank of said Willow Creek to the intersection of said left bank with the line between the North half of the Southeast Quarter of the Southwest Quarter and the South Half of the Southeast Quarter of the Southwest Quarter (between N_2^1 SZ $_2^1$ SW $_3^1$ and S_2^1 SW $_4^2$ of said section Thirty-two (32); thence Westerly tracing said line to the intersection with the right bank of said Willow Creek; thence Southeasterly with the meanders of said right bank of said Willow Creek to its intersection with the South line of said Section Thirty-Two (32); thence Easterly tracing said line to the Southeast corner of said Southwest Quarter (Salt) of said Section Thirty-Two (32); thence North tracing the East line of said Southwest Quarter to the center of said

Section Thirty-Two (32) being the place of Beginning, excepting therefrom the railroad right-of-May, all of the above described land being in Section Thirty-two (32) Township Fifteen (15) South of Hange Forty-Three (43) East of the Willamette Meridian, Malheur County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
