## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That ORVILLE MUILENBERG

of Route 4, Box 354, Sherwood , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Tualatin River a tributary of Willamette River for the purpose of

irrication
under Permit No. 13400 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from January 6, 1939;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.38 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $SW_+^1$ ,  $SE_+^1$ , as projected on Phillip Harris DLC #53, Section 32, T. 1 S., R. 2 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightlieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described as follows: Beginning at the most westerly angle corner on the West line of the Phillip Harris Donation Land Claim; said corner being marked by a 2" iron pipe set to replace a yew wood stake; Thence South 43°09' 09" East 1693.21 feet along the Phillip Harris Donation Land Claim line to a point on the center line of the Tualatin River, said point being referenced by a 2" iron pipe set back on line 110.00 feet; Thence meandering the center line of the Tualatin River as follows: North 20°38'20" East 597.32 feet; North 13° 49' 21" East 393.36 feet; North 41° 20' 14" East 341.46 feet; South 85° 14' 08" East 489.04 feet; South 79° 25' 03" East 160.58 feet to a point which is also the Southwest corner of United States Farm Security Administration Farm Unit No. 101, and which is referenced by a 3/4" iron pipe North 186' 19" East 168.12 feet, Thence North 18° 46' 19" East 967.24 feet along the line common with Farm Unit No. 101 to a point marked by a 3/4" iron pipe; Thence South 83° 59' 41" East 88.57 feet along the line common with Farm Unit No. 101 to a point marked by a stone set in County Survey No. 1708, said point being in the center line of the County road; Thence North 83° 59' 41" West 1449.04 feet along a line common with the F. G. Mitchell property to a point on the center line of the Tualatin River, said point being referenced by a 2" iron pipe set back on

line 150.00 feet; Thence meandering the center line of the Tualatin liver as follows: South 36° 00° 15" West 606.39 feet; South 44°32'09" West 425.60 feet; South 77° 25°30" West 116.53 feet; North 69° 32' 55" West 375.25 feet to a point on the West line of the Phillip Harris Donation Land Claim, said point being referenced by a 2" iron pipe set South 33° 50' 51" West 130.00 feet; Thence South 33° 50' 51" West 334.25 feet along the West line of the Phillip Harris Donation Land Claim to the point of beginning. This Unit contains 60.053 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
