CERTIFICATE OF WATER RIGHT

This Is to Certify, That HECTOR MACPHERSON

of Route 3, Albany, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Muddy Creek a tributary of Willamette River for the purpose of irrigation under Permit No. 12956 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 23, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.50 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected in John G. Wilson DLC #60, Section 20, T. 12 S., R. 4 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.8 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$
24.8 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on John G. Wilson DLC #60
Section 20
10.4 acres in NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on John G. Wilson DLC #60
Section 21
T. 12 S., R. 4 W., W. M.

Land on which water is to be used is a part of that more explicitly described as follows:

Beginning at a point 1.13 chains West of the quarter Section corner between Sections 20 and 21, Township 12 S., Range 4 West of the Willamette Meridian, in Linn Co. Oreg. thence East 1950 chains; thence South 15 deg. 30' West 40.05 chains; thence South 86 deg. 30' West 28.45 chains; thence South 2 deg. 30' West along the boundary of the original D.L.C. John G. Wilson and Ruth Wilson, his wife, Not. No. 2027 and down the center of the main channel of said creek and following the meanders thereof to a point directly West of a point on the West boundary of said D.L.C. located 10.38 chains South 2 deg. 30' West of the angular corner in the West boundary of said D.L.C. and in section 20 and Township and Range described; thence East 30.96 chains, more or less to a point 4.86 chains west of the west boundary of said D.L.C.; thence North 2 deg. 30' East 10.26 chains; thence East 4.86 chains to the angular corner in the West boundary of said D.L.C. and heretofore described; thence North along the boundary 26.79 chains to the Northwest corner of said D.L.C.; thence continuing North 9.09 chains, more or less, along the boundary of the original D.L.C. of Washington B. Mealey, Not. No. 2029, to the intersection of said boundary with the boundary of the public highway; thence following the southern boundary of said public highway in a Southwesterly direction to the center of Muddy Creek, 11.85 chains, more or less; thence up the center of the main channel of Muddy Creek to where the same crosses the North boundary of the John G. Wilson D.L.C., 1.51 chains, more or less; thence East along the Northern boundary of the John G. Wilson D.L.C. to the place of beginning, enclosing 180.88 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
