## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** FRANK A. LINGSCHUIT

of Route 2 - Sheridan, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Deer Creek a tributary of Yamhill River for the purpose of irrigation under Permit No. 11803 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 5, 1935

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.143 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ , NE $\frac{1}{4}$  & SW $\frac{1}{4}$ , NE $\frac{1}{4}$ , Section 25, T. 4 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.6 acres in NW $\frac{1}{4}$ , NE $\frac{1}{4}$   
6.8 acres in SW $\frac{1}{4}$ , NE $\frac{1}{4}$   
Section 25  
T. 4 S., R. 6 W., W.M.

Land on which water is to be used is a part of that more explicitly described as follows: The Wouthwest  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  of section 19 in township 4 South Range 5 West of the Willamette Meridian, containing 41.76 acres. Also, beginning at a point on the Section line 11.32 chains North of the  $\frac{1}{4}$  section corner on the East line of Section 25 in Township 4 South Range 6 West of the Willamette Meridian; thence West 30' North 23.40 chains; thence South 1°30' East 4.48 chains; thence West 15.50 chains; thence North 51°30' West 1.00 chains; thence North 56° West 1.78 chains to a point on the center line of said section 25, which point is 31.90 chains South of the  $\frac{1}{4}$  section corner between sections 24 and 25; thence North along said center line 10.40 chains; thence North 19° 45' East 2.12 chains; thence North 45' East 2.09 chains; thence North 9° East 1.47 chains; thence North 13° 30' West 1.00 chain; thence North 2°15' East 6.15 chains; thence North 12°15' East 2.04 chains; thence N. 31°30' East 3.61 Chains; thence North 18°45' East 2.05 chains; thence North 8° 45' East 2.89 chains; thence North 13° 30' West 1.00 chain to a point on the section line 4.00 chains East of the  $\frac{1}{4}$  section corner between sections 24 and 25; thence North 23° West up Deer Creek 2.00 chains; thence North 44° East 8.20 chains to a point in County road leading up Deer Creek; thence meandering up County road as follows; North 26° 30' West 2.00 chains; thence North 3° 30' W. 3.65 chains; thence North 28° East 4.20 chains; thence North 10° W 8.90 chains to the South line of a certain 93 acre tract; thence East along the South line of said 93 acre tract 31.70 chains to the East section line of section 24; at a point 14.08 chains South of the  $\frac{1}{4}$  section corner on East line of Section 24, Township 4 South range 6 West of the Willamette Meridian; thence South along said section line 25.92 chains to the Southeast corner of said section 24;

Thence South along the East line of said Section 25, 28.68 chains to the place of beginning, containing 200.5 acres, more or less, in sections 24 and 25 in township 4 South Range 6 West of the Willamette Meridian in Yamhill County, Oregon.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
