**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** John Herinckx

of Route 1, Box 33 - Cornelius, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Dairy Creek a tributary of Tualatin River for the purpose of irrigation under Permit No. 16211 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 14, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.375 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 21, T. 1 N., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

7.0 acres in Lot 1 (NW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
3.0 acres in Lot 2 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
18.7 acres in NE $\frac{1}{4}$  NW $\frac{1}{4}$   
1.3 acres in SE $\frac{1}{4}$  NW $\frac{1}{4}$

Section 21, T. 1 N., R. 3 W., W. M.

Land on which water is to be used is a part of that more explicitly described as follows: Commencing at the North East corner of the D.L.C. of John Marsh on the north line of Section twenty one(21) in township one(1) north of range three(3) West of the Willamette Meridian and running west on section line to the east bank of Dairy Creek thence down said creek with the meanderings thereof to the east line of the said claim of John Marsh thence North on the east line of the aforesaid said claim to the place of beginning, containing forty(40) acres more or less, also beginning at the North west corner of the D.L.C. of Michael Wren and wife in section twenty one(21) township one(1) North of range three(3) west of the Willamette Meridian thence East along the north line of the said D.L.C. sixty one (61) rods, thence south twenty (20) feet, thence west sixty one(61) rods, thence North twenty(20) feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
