CERTIFICATE OF WATER RIGHT

This Is to Certify, That Edward J. Sattler

of Route 2, Box 40 - Tigard, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Unnamed stream a tributary of Fanno Creek for the purpose of irrigation under Permit No. 16235 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 20, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.125 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Soloman Richardson Claim #44, Section 11, T. 2 S., R. 1 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.8 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Soloman Richardson Claim #44
- 2.0 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on Soloman Richardson Claim #44
- 3.2 acres in NE $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Soloman Richardson Claim #44
- 3.0 acres in NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Soloman Richardson Claim #44

Section 11, T. 2 S., R. 1 W., W. M.

Land on which water is to be used is a part of that more explicitly described as follows:

Commencing on the North line of the D.L.C. of Solomon and Elizabeth Richardson in Sec 11 T 2 S R 1 W of the W. M. in said County and State at a point 17.15 chs W of the Northeast corner of said claim; thence running S 16.314 chs; thence W. 5.7125 chs; thence N 16.298 chains to the N line of said claim; thence E on the said N line 5.7125 chains to the place of beginning, containing 9.52 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
