## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That Walter W. Sandstrom

of P. O. Box 115 - Sheridan , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Fork Yamhill River a tributary of Yamhill River for for the purpose of irrigation under Permit No. 16551 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 29, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.113 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NE_{+}^{2}$ ,  $NN_{+}^{2}$ , as projected in James B. Graves D.L.C. No. 42, Section 34, T. 5 S., R. 6 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.4 acres in NEL NW4, as projected in James B. Graves DLC #42 7.6 acres in NW4 NW4, as projected in James B. Graves DLC #42 Section 34, T. 5 S., R. 6 W., W. M.

Land on which water is to be used is a part of that more explicitly described as follows: Beginning at an iron pin set in the center of the County road 13.36 chains North and 30.41 chains East of the South West corner of the James B. Graves Donation Land Claim Notification Number 6710. Claim Number 42 in Township 5 South, Range 6 West of the Willamette Meridian in Yamhill County, State of Oregon; thence North 1°5' East 10.88 chains; thence North 88°47' East 10.40 chains to Bewley's line in center of ditch; thence south 84° East along said Bewley's line 7.08 chains to iron pin set in center of former County Road now State Highway #18; thence South 69° Vest 18.40 chains to the place of beginning, containing 10 acres, save and except one acre deeded to E. Blake Baird on July 3, 1907 by Ralph R. Barber and Pearl B. Barber, by deed recorded Oct. 3, 1907 in Book 52 Deeds page 70 for Yamhill County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
