that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.23 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the West 2, Section 31, T. 30 S., R. 5 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 1/70th of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season from April 1st to October 1st of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is 12 acres ,domestic and stock NEt SW4 3 acres in SE4 NW4 appurtenant, is as follows:

Section 31, T. 30 S., R. 5 W., W. M.

Land on which water is to be used is a part of that more explicitly described as follows: Beginning at a point from which a stake on the section line between Sections 31, and 32. 20.00 chains south of the corner of Sections 29, 30, 31 and 32 Township 30 South, Range 5 West of the Willemette Meridian, bears North 89 degrees 23 minutes E. 20.00 chains; thence S. 89 degrees 23 minutes W. 29 chains; thence S. 30 degrees 45 minutes W. 9.50 chains; thence S. 19 degrees 30 minutes E. 3.00 chains; thence S. 4 degrees 35 minutes E. 3.50 chains; thence S. 32 degrees 20 minutes W. 6.50 chains; thence S. 21 degrees 00 minutes W. 2.00 chains; thence S. 42 degrees 00 minutes W. 8.50 chains; thence S. 4 degrees 00 minutes E. 1.50 chains; thence S. 13 degrees 30 minutes E. 3.00 chains; thence S. 32 degrees 30 minutes E. 8.00 chains; thence S. 3 degrees 00 minutes W. 21.25 chains; thence S. 32 degrees 30 minutes E. 8.00 chains; thence S. 3 degrees 00 minutes W. 21.25 chains; thence N. 89 degrees 33 minutes E. 38.50 chains; thence N. 60 chains to the place of beginning containing 220.79 acres more or less.
