has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from November 10, 1945

that the amount of water to which such right is entitled and herebu confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.84 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SEL SML, as projected within Jacob Wooley D.L.C.
No. 49, Section 26, T. 1 N., R. 3 N., N. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year, a

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.2 acres in SW# NW#, as projected in Jacob Wooley D.L.C. #49
20.4 acres in SE# NW#, as projected in Jacob Wooley D.L.C. #49
30.3 acres in NE# SW#, as projected in Jacob Wooley D.L.C. #49
6.5 acres in NW# SW#, as projected in Jacob Wooley D.L.C. #49
4.6 acres in SE# SW#, as projected in Jacob Wooley D.L.C. #49
Section 26, T. 1 N., R. 3 W., W. M.

Land on which water is to be used is a part of that more explicitly described as follows: Commencing at the S.W. Corner of Jacob Wooley D.L.C. #49 in T. 1 N. R. 3 W. Will.Mer., and running thence S. 88 deg. 40' E. following South line of said Wooley D.L.C. 19.18 chs., thence N. 25' E. 44.88 chs. to South boundary line of County Road #344, thence N. 88 deg. 40' W. 19.18 chs. to west boundary line of said Wooley D.L.C. thence S. 22' E. following said W. line of Wooley Claim 45.16 chains to place of beginning. Containing 87.47 acres, excepting that piece, parcel, and tract lying south of Dairy Creek, and adjoining the Southern boundary of the above described tract, consisting of 1 acre more or less, which was transferred by Jacob Schnieder and Josephine Schnieder, (his wife) to Daniel Denville; also including all that piece or parcel of land lying north of Dairy Creek and South of that certain tract conveyed by L. O. KcCoy and Sylvia McCoy to Jacob Schnieder and Josephine Schnieder by deed dated 12 Dec., 1922 and recorded 12 Dec. 1922 in Book 124 Pg. 382 Deed Records, Wash., County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
