CERTIFICATE OF WATER RIGHT

This Is to Certify, That HEREERT M. RODINSON

of Route 1, Box 21 - Cornelius , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Dairy Creek

a tributary of Tualatin River irrigation

for the purpose of

under Permil No. 17628 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Earch 24, 1947

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.28 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE_{4}^{1} , NE_{4}^{2} , as projected in John Beal D.L.C. No. 64, Section 28, T. 1 N., R. 3 N., W. K.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2¹/₂ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

> 5.8 acres in NEA NEA, as projected in John Beal D.L.C. No. 64 16.7 acres in NWA NEA, as projected in John Beal D.L.C. No. 64 Section 28, T. 1 N., R. 3 W., W. M.

Land on which water is to be used is a part of that more explicitly described as follows: Commencing at the N.E. corner of the John Beal D.L.C. on Sec. line between Sections 21 and 28 in Township No. 1-N. R. No. 3 West in Jashington Co., State of Ore. Thence West on said section line 26.13 chs to the N.E. corner of a tract of land owned by Herod Corun, thence South 19 degrees, 30' East on East line of said Corum's land, 16.38 chs. to a rock in Co. road, thence South 27 degrees East 3.82 chs. to the boundary line of said Beal land claim, thence North 54' deg 45' East. 23.32 chs., thence north 5.12 chs. to the place of beginning and containing 30.49 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
