of Route 1, Eax 170 - Rogue River , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of waste water

under Permit No. 18298 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from June 3, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.063c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NE4, section 4, T. 35 S., R. 4 M., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4½ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year, and shall not carry with it the right to enforce the continuance of such waste water at permittee's point of diversion,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.0 acres in SEt NEt, Section 4 T. 35 S., R. 4 W, W. M.

Land on which water is to be used is a part of that more explicitly described as follows: All of the Northeast Quarter of the Northwest Quarter, and the Southwest Quarter of the Northwest Quarter of Section 3; and all that part of the Southeast Quarter of the Northeast Quarter of Section 4, lying Easterly of the West bank of Fleasant Creek; all in Township 35 South of Range 4 West of the Willamette Meridian, in Jackson County, oregon

Excepting the following described property: Beginning at the Northwest corner of the Southeast Quarter of the Northeast Quarter of Section 4, in Township 35 South of Range 4, West of the Willamette Meridian, in Jackson County, Oregon; thence East, along the North line thereof, 468.0 feet to the Westerly line of the County Road; thence South, 15°30' East, along the Westerly line of said road, 430.12 feet; thence West, 582.9 feet to the West line of said Southeast Guarter of Northeast Guarter; thence North, 414.48

feet to the point of beginning.

Less, beginning at the Northwest corner of the Southeast Quarter of the Northeast Quarter of Section 4, in Township 35 South of Range 4 West of the Willamette Meridian in Jackson County; thence South 414.48 feet to the true point of beginning; thence East, 582.9 feet to the Westerly line of County Road; thence South 15°30' East, along the Westerly line of said Road, 415 feet; thence West 300 feet, more or less, to the West bank of Pleasant Creek; thence North 15°30' West, along the West bank of Pleasant Creek, 250 feet, more or less, to a point directly South of the point of beginning; thence N, 200 feet, more or less, to the true point of beginning.

Less, heginning at the Northwest corner of the Southeast Quarter of the Northeast quarter of Section 4 in Township 35 South of Range 4 West of the Willamette Meridian in Jackson County, Cregon; thence East, 468. feet; thence South 15°30' East, along Westerly line of County Road, 845.12 feet to the true point of beginning; thence West, 300 feet, more or less, to the West bank of Pleasant Creek; thence South along West bank of Pleasant Creek, 500 feet, more or less, to the Half Section line; thence East, 375 feet,

more or less, to the Westerly line of County Road; thence North 15°30' West, along Westerly line of County Road, 520 feet, more or less, to the true point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to tile lands or place of use herein described.
