## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That BRUCE V. MILLAM

of Route 1, Box 40 - Dayton , State of Cregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Palmer Creek atributary of Yamhill River for the purpose of irrigation

under Permit No. 18352 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 29. 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.562 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SWL SEL, as projected in the Alvis Kimsey D.L.C. #43, Section 5, T. 5 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer. When in the distribution of water it becomes necessary to install headgates and measuring devices, the applicant or his successor in interest will be required to install these so as not to restrict the natural channel of the stream or interfere with the flow of the water therein.

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.0 acres in SE, SW, as projected in Alvis Kimsey D.L.C. #43
18.0 acres in NW, SEC, as projected in Alvis Kimsey D.L.C. #43

23.4 acres in SWG SEE, as projected in Alvis Kimsey D.L.C. #43

Section 5

0.2 acres in NE, NW4, as projected in Alvis Kimsey D.L.C. #43

2.4 acres in NWA NEA, as projected in Alvis Kimsey D.L.C. #43 Section 8, T. 5 S., R. 3 W., W.M.

Land on which water is to be used is a part of that more explicitly described as follows: A part of the East half of the D.L.C. of Alvis Kimsey & wife in Sec. 5 6 7 & 8 T 5 S R 3 W of W. M. Yamhill County, Oregon Begin Lot #2 of County Survey #2775.

The right to the use of the water for the purposes aforevaid is restricted to the lands or place of use herein described.
