This Is to Certify, That HAROLD CHRISTENSEN

of Route 2, Box 194 - Scio , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of North Santiam River

a tributary of Santiam River irrigation

for the purpose of

under Permit No.18495 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 20, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.176 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE_{τ}^{\pm} SE $_{\tau}^{\pm}$, Section 19, T. 9 s., R. 1 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.0 acres in SE, SE, Section 19
0.3 acres in SW, SW, 7.8 acres in SW, SW, Section 20
T. 9 S., R. 1 W., W.M.

Land on which water is to be used is a part of that more explicitly described as follows: Beginning at a point that is 14.50 chains west of the southeast corner of the northwest quarter of the northwest quarter of Section No. 29, in Township No. 9 South, Range No. 1 West of the Willamette Meridian, Oregon, and running thence north 19.32 chains thence east 14.50 chains; thence north 9.66 chains; thence west 14.50 chains; thence north 24.62 chains, More or less to the south bank of the North fork of the Santiam River; thence westerly and southwesterly following the meanderings of said river, to the point due West of the place of beginning; thence east 21.92 chains, more or less, to the place of beginning, containing 75.79 acres, mere or less excepting therefrom a roadway heretofore conveyed by deed recorded in Volume 109 of the Deed Records for Linn County, Oregon at page 622 there in, all of said premises, situated, lying, and being in Linn County, State of Oregon.

Also excepting a roadway as conveyed by deed recorded on page 532 of Volume 134 of the Deed Records for Linn County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
