CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. A. WARD

of Route 1, Box 22 - Halsey, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Calapooia River a tributary of Willamette River for the purpose of irrigation under Permit No. 19327 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 6, 1950

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.607 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE₁, NE₂, as projected on Elias L. Walter D.L.C. #38, Section 35, T. 13 S., R. 3 W., W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 13.6 acres in SW₁, NE₂, as projected on Thomas Hall D.L.C. #48
 - 0.5 acre in SW₁, NE₂, as projected on Elias L. Walter D.L.C. #38
 - 0.2 acre in SE₁, NE₂, as projected on Elias Walter D.L.C. #38
 - 12.4 acres in SE₁, NW₂, as projected on Thomas Hall D.L.C. #48
 - 3.4 acres in NE₁, SW₂, as projected on Thomas Hall D.L.C. #48
 - 3.4 acres in NE₁, SE₂, as projected on Elias L. Walter D.L.C. #38
 - 2.5 acres in NW₁, SE₂, as projected on Elias L. Walter D.L.C. #38
 - 12.4 acres in NW₁, SE₂, as projected on Thomas Hall D.L.C. #48
- Section 35, T. 13 S., R. 3 W., W. M.

Land on which water is to be used is a part of that more explicitly described as follows: Beginning at the North West corner of the DLC of Elias L. Walter and wife, same being Not. No. 2134 and Cl. No. 38 in T. 13 S. of R. 3 W. of the W. M., Oregon, and running thence S. along the W. boundary line of said claim 30.50 chains, thence E. 6.557 chains, thence N. 30.50 chains, thence W. 6.557 chains to the place of beginning, and containing 20 acres, more or less, all lying and being in the County of Linn and State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
