CERTIFICATE OF WATER RIGHT

This Is to Certify, That LAWRENCE J. LAMB

of Route 3, Box 416, Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, for a right to the use of the waters of Applegate River a tributary of Rogue River for the purpose of irrigation and supplemental of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 16, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the S. 1/4, Section 16, T. 37 S., R. 6 W., 1. N.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be applied is a part of that more explicitly described as follows: Beginning at the Southeast corner of the Southeast Quarter of the Northwest Quarter of Section 16, Township 37 South, Range 6 West of the S. M., and run N. 80 rods, to the northeast corner of said subdivision; then West 60 rods; thence South 80 rods to the South line of said subdivision; then S. 80 rods to the point of beginning.

Less and excepting the following described land: Beginning at the Northwest corner of the Southeast Quarter of the Northwest Quarter of said Section 16 and running thence South 60 rods, thence East 16 1/2 feet; thence North 65 rods; thence West 16 1/2 feet to the Place of beginning, containing 35 rods of land.

Also less and excepting: Beginning at a point on the South line of the first above described tract 60 rods W. of the Southeast corner of said tract and run N. 20 rods; then Northeasterly 37 rods to a point which is 25 rods distant W. from the S. line of the Southeast Quarter of the Northwest Quarter of said Section, Township and Range; then Southeasterly 32 rods to the South line of said Southeast Quarter of the Northwest Quarter, at a point 13 rods West of the Southeast corner of said subdivision; thence West along said South line 47 rods to the point of beginning.

Granting also 6 shares in the Wilderville Irrigation Company Ditch and Water rights.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
