# CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** GLADYS A. SILVA

of Route 3, Box 416 - Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Applegate River, a tributary of Rogue River, for the purpose of irrigation and supplemental irrigation under Permit No. 15740 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 16, 1946

; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed .08 c.f.s.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE 1/4, Section 16, T. 37 S., R. 6 W., M. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described as follows: Beginning at the Northwest corner of the Southeast Quarter of the Northwest Quarter of Section 16, Township 37 South, Range 6 West of the M. M., and run E. 20 rods; then S. 80 rods to the S. line of said subdivision; then E. along the S. line 20 rods to the SW corner of said subdivision; then N. along the W. line of said subdivision 80 rods to the point of beginning.

Less and excepting the following described land: beginning at the NW corner of the SE Quarter of the NW Quarter of said Section 16, and running thence S. 60 rods; thence W. 16 1/2 feet; thence N. 65 rods; thence E. 16 1/2 feet to the place of beginning, containing 65 rods of land.

Granting also 6 shares in the Wilderville Irrigation Company Ditch and water right. Recorded at page 591, of Volume 150. Deed Records of Josephine County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
