CERTIFICATE OF WATER RIGHT

This Is to Certify, That JOHN P. & RENA B. MC CRONE

of Box 259, Aurora, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River a tributary of Molalla River for the purpose of irrigation under Permit No. 12712 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 11, 1937

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.215 cubic feet per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 13, Township 4 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

10.0 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$
4.4 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$
2.8 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 13
Township 4 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Beginning at a point in the N and S 1/4 line through the center of Sec. 13, T. 4 S., R. 1 W., W. M., which bears S 1089.4 ft. from the 1/4 section corner on the N line of said Section 13; thence S along said N and S 1/4 line 525.0 ft. to a point which bears N 1024.0 ft. from an iron pipe at the center of the aforesaid Sec. 13; thence E 285.36 ft. more or less, to a point on the W line of line of a tract deeded to James R. Marsh as recorded on Page 287 in Deed book 106 in records of Marion County Oregon; thence N along west line of said Marsh tract, 95.0 ft. to the NW corner of said tract; thence E 1068.41 ft., thence S 330.76 ft., thence E 505.7 ft. to the center of Pudding R., thence along the center of Pudding R., North 41°00' W 770.0 ft., thence along center of Pudding R. N 16°00' W. 800.0 ft., thence along center of Pudding R., N. 70°00' W. 150.0 ft., thence along center of Pudding R., S 57°00' W. 600 ft., thence along center of Pudding R. N 58°48' W. 142.88 ft., thence S 140.0 ft. thence S. 84°34' W. 136.5 ft., thence S 19°37' W. 137.0 ft., thence S. 72.0 ft. thence W. 200.76 ft. to the point of beg., save and except all streets, roads. Also:

Beginning at a point in the N & S 1/4 line through the center of Sec. 13, T. 4 S., R. 1 W., W. M., which bears S 862.4 ft. from the 1/4 section corner on the N line of said Sec. 13; thence S. along said N and S 1/4 line 227.0 ft. thence E 200.76 ft. thence N. 72.0, thence N 19°37' E. 173.0 ft., thence S 88°14' 20" West 258.96 ft. to the point of beginning save and except all streets and roads. All situated in Marion County, Oregon

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
