CERTIFICATE OF WATER RIGHT

This Is to Certify, that WALTER J. GEARIN

of Star Route, Newberg , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream and Willamette River a tributary of Willamette River and Columbia River

irrigation

for the purpose of

under Permit No. 13768 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 24, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.648 cubic feet per ser , being 0.023 c.f.s. from unnamed stream and 0.625 c.f.s. from Willamette h. ar,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the River: NE4 SW4, as projected on E. Lucier D.L.C. No. 65, Section 33, Township 3 South, Range 2 West, W.M., Stream: NE4 NW4, Lot. 9, Section 4, Township 4 South, Range 2 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres in Lot 6 (NE $\frac{1}{4}$ SW $\frac{1}{4}$)
23.0 acres in Lot 9 (SE $\frac{1}{4}$ SW $\frac{1}{4}$)
3.0 acres in Lot 7 (NW $\frac{1}{4}$ SE $\frac{1}{4}$)

22.4 acres in SWE SEE

Section 33, Township 3 South, Range 2 West, W. M. 3.0 acres in Lot 8 (NW 1 NE 1) 1.2 acres in Lot 9 (NE 1 NW 2)

1.8 acres in Lot 9 (NE4 NW4) from Unnamed stream Section 4

Township 4 South, Range 2 West, W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
