CERTIFICATE OF WATER RIGHT

This Is to Certify. That WARREN C. BAUGH

, State of Oregon , has made proof Cornelius to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of East Fork of Dairy Creek

a tributary of Dairy Creek

for the purpose of

irrigation under Permit No. 16048 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 3, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.805 cubic foot per second.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 SW4 & NW4 SE4, Section 34, Township 2 North, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.4 acres in NE4 SW4, as projected on John Harrison D.L.C. No. 37 5.0 acres in MM SW4, as projected on John Harrison D.L.C. No. 27
1.2 acres in SW4 SW4, as projected on John Harrison D.L.C. No. 37
11.4 acres in SW4 SW4, as projected on John Harrison D.L.C. No. 37
4.8 acres in MM SE4, as projected on John Harrison D.L.C. No. 37 23.6 acres in SWA SEA, as projected on John Harrison D.L.C. No. 37 Section 34

Township 2 North, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by applicant as follows:

Commencing at the NE cor. of the DLC of John and Mary Harrison in Sec. 35, T. 2 N., R. 3 W., running thence S 12° 30' W. 22.85 chains, thence N 77° 30' W. 70 chains, thence N. 12° 30' E. 22.85 chains, thence S. 77° 30' each 70 chains to the place of beginning.

Excepting therefrom tract conveyed by Maud Shannon Tongue, widow of E. B. Tongue, deceased, to State of Oregon, by and through its State Highway Commission, as described in deed bearing date 30 July 1941, and recorded 3 September 1941, in deed book 201, page 649, records of Washington County, Oregon.

Also excepting therefrom tract conveyed by Francis Paul Bailey and Frances Bailsy, husband and wife, Edmund Burke Tongue, Jr. and Joy Snead Tongue, husband and wife, and Robert S. Tongue, an unmarried man, to the State of Oregon, by and through its State Highway Commission, as described in deed bearing date 28 July 1941, and recorded 3 September 1941, in deed book 201, page 693, records of Washington County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
